## 3 Matters arising from previous Minutes

## <u>3a - Highways issues – Rising Lane</u>

The Clerk has again contacted Peter Hallam at WCC to report the issue of potholes in Rising Lane towards the Birmingham Road junction.

#### 3b – Hay Wood parking issues

Cllr Richard Roberts reported that a parked car outside Hay Wood had had its window smashed. Also Councillors commented upon the difficulty passing badly parked vehicles and the damage to the verges along the verges near the lay-by for the wood. The Chairman stated that there have been over 50 vehicles parked along this stretch of the lane on occasions.
