1 Apologises/Welcome

2 Minutes of previous meeting held 10 February 2021

Agreed and signed.

3 Matters arising from previous Minutes

3a – Hay Wood parking issues

Councillors reviewed parking issues at Hay Wood. They commented that since the easing of Covid restrictions there seemed to be fewer vehicles at the Wood and consequently the additional parking suggested at the February meeting may no longer be required. Councillors agreed to monitor the situation and report back at the next meeting.

3b - Removal of hoardings Rising Lane/Birmingham Road

Councillors agreed to pursue the Planning Department to ensure an Enforcement Notice is issued requiring the developer to remove the hoardings after their unsuccessful attempt to secure planning permission for 2 dwellings on the site, and a failed Appeal.

3b - Proposed cell mast - Bakers Mews

Councillors discussed at length the application to erect an 18 metre monopole outside the Bakers Mews properties, on the corning of Rising Lane/Birmingham Road, and the Chairman stated all the residents in Bakers Mews were advised of the application via circular letter. It was agreed The Parish Council would lodge a strong objection to the application citing a number of issues. Additionally, Councillors agreed the layby on the Birmingham Road would be an infinity preferable location for the mast.

3d – Parish Council website

The Clerk advised issues with the updating of the Parish Council website still exist and it may be necessary to source another contract to ensure site remains current.

4 Warwick Rural West Community Forum

5 Warwick District Council

District Councillor George Illingworth was unable to attend the meeting but forwarded a Report, on current issues at WDC which the Parish Clerk forwarded to Councillors.
