1 Apologises/Welcome

3 Matters arising from previous Minutes

3a Matters arising

It was stated that the frequency of The Convent Farm bonfires is more intrusive in the summer than in the winter, and Councillors agreed to keep monitoring the situation and discuss at the next meeting.

3b Condition of carriageway Rising Lane

Councillors commented that the WCC have done an excellent job in resurfacing the area of Rising Lane between Baddesley Clinton Hall NT property and part way towards the bridge at Lapworth. However, they expressed disappointment that the area repaired was not extended as the condition of Rising Lane continues to get worse and worse, and repairs to the carriageway in the village are unlikely to happen for several years. Councillors requested the Clerk to contact County Councillor John Cooke and the Highways Officer, Mike Newham on this matter.

3c Speed Watch

The Clerk reported the organiser of Speed Watch has returned from long term sick leave and has enquired as to whether potential volunteers have been vetted. He will forward the relevant vetting forms and the Clerk will liaise with the contact at Chadwick End, Sam Jackson, with regard to setting up a joint strategy.

3d State of Public footpath/Bridleway leading from Convent Farm - Netherwood Lane

Clr Morris previously reported that the current state of the public footpath leading from Convent Farm to Netherwood Lane is waterlogged and impossible to use. The Clerk reported this issue to the Rights of Way Officer, Richard Barnard at Warwick District Council and sent several reminders and has been advised he will visit the site week commencing 16 December 2024.

4a- Warwick District Council – planning applications

The Clerk had been advised by WDC that an application by Lynton Croft has been withdrawn, although no notification of the original application had been received by the Parish Council. Councillors requested the Clerk contact the Planning Department to establish the current situation with 'Oaklands' on Haywood Lane.

4b - Warwick District Council Update

Unfortunately all District Councillors were unable to attend, however all current WDC issues were covered in their recent monthly report, which was circulated to all Parish Councillors.
