1 Apologises/Welcome

Present: Cllr Laurence Mathers (Chairman), Cllr Richard Roberts, Cllr Michael Morris, Cllr Robert Blyth and District Cllr Kyn Aizlewood.

3 Matters arising from previous Minutes

3a Matters arising

Parish Councillors discussed the issue of The Convent Farm bonfires and house bonfires and Cllr Morris reported that the issue was not currently. Councillors agreed to keep monitoring these issues and discuss at the next meeting.

3b Condition of carriageway Rising Lane

Councillors expressed concern regarding the condition of Rising Lane, as it has substantially deteriorated over the winter months. Chairman, Cllr Mathers had circulated an email from WCC Highways stating that carriageway repairs for the section of Rising Lane from the NT property to the bridge were planned for October, but that repairs to the carriageway in the village are unlikely to happen for several years.

3c Speed Watch

The Chairman, Cllr Mathers, reported there was no further progress on the possible link up with Chadwick End Parish Council volunteers to run a joint course of action on speeding in the area, as the organiser is on sick leave. The Chairman will follow up in due course.

Additionally, concerns were expressed relating to the dangers of football games being played on the Village Green, both to road users and players in the event of a stray ball crossing into the road, near the blind bend where traffic approaches at speed. Cllrs agreed to explore reinstating the 'No Ball Games' sign which previously existed on the Village Green and to potentially speak to those concerned explaining the risks giving rise to these concerns.

3d State of Public footpath/Bridleway leading from Convent Farm - Netherwood Lane

Clr Morris reported that the current state of the public footpath leading from Convent Farm to Netherwood Lane is waterlogged and impossible to use in its present state. The Clerk offered to report this issue to the Rights of Way Officer, Richard Barnard at Warwick District Council.

4a- Warwick District Council – planning applications

The Clerk advised Manor Park Farm's application for a new access entrance had been Granted. A planning application was received for 15 Rising Lane, a renewal of a previously Granted application.

4b - Warwick District Council Update

District Councillor Kyn Aizlewood advised all current WDC issues were covered in the recent monthly report, which was circulated to all Parish Councillors.

5 Warwickshire County Council

County Cllr. John Cooke was unfortunately unable to attend, however a copy of his monthly report on WCC matters was received and circulated to all Parish Councillors.
